All DC Department of Health permits and licenses will be provided by Restaurant Associates (RA). Although alcohol isn't currently on the menu, if it were to be in the future, RA would be responsible for any required permitting. Contractor will be responsible with permitting as indicated in Division 1 specifications.
				The following is not direction. How to obtain construction site power is part of the Contractor's Means and Methods, and shall be coordinated with the COTR.
				Following are some suggestions the Contractor may consider. Construction site power can come from the following sources. For the Cafe, use the floor boxes supplied from circuit LP1C1-38. The panel is located in electrical room 1096. See B1 POWER PLAN, A1/EP103PP. For most of the time, floor boxes supplied by Panel LPGA, circuits 12 and 16, and a wall receptacle in the northwest, supplied by Panel ELPGA, circuit 12, will be available.

For the Pantry 0015, the source of construction site power will change during the project. Initially, power can come from the existing Panel LPGA. When it is removed and replaced with temporary load center LPGA, the temporary load center can be used for construction site power. After the temporary load center is replaced with permanent panelboard LPGA, the permanent panelboard can be used for construction site power. Construction site power for the Pantry might also be sourced from Temporary Load Center LPMA or Panel LPMA, located in the Mezzanine below the Pantry.
				For the mezzanine, construction site power can be obtained from Temporary Load Center LPMA, supplied by a new feeder from existing Panel LDP1C. LDP1C is located in electrical room 1096. See B1 POWER PLAN, A1/EP103PP. Contractor may wish to consider providing Temporary Load Center LPMA and its feeder to LDP1C at the start of the project.
				For Kitchen 2020, construction site power can be obtained from Panel LP2A5 in the kitchen, or from the receptacles in the kitchen. When LP2A5 is being replaced, construction site power can be obtained from Panel LP2A2 in nearby Electrical Room 2015. This work shall be coordinated with the COTR.
				Elsewhere in the building, construction site power can be obtained from existing receptacles JPA/MRH

ARUP: GC shall submit any field change request (per their survey) with their proposed alternative solution via RFI to COTR, which may cause COTR to make design changes based on the impact from field survey.

Item E7 Cashroom Network Rack is not included in this amount and should be provided under the base bid.

8/1/24	8		Will the workers/personnel be allowed to use the public toilet?	Yes, the public toilets that can be used are on Sublevel 1 during public hours. Work done outside of public hours will require SI security escorts during construction and access to restrooms. Non-public restrooms require an escort during public hours and non-public hours. If, in the opinion of the COTR, the Contractors' personnel fail to maintain acceptable dress and conduct appropriate to a public place, permission to use the public restrooms may be rescinded.

Can you please confirm all items not shown are existing to remain?	We have updated A106 to indicate that all equipment shall be removed unless noted as existing to remain on QF101.

The contractor should arrange for their own dumpster or disposal truck. Per OFMR, maximum allowable time for a dumpster to remain on site is 5 days. SI COTR can coordinate with OFMR/NMAA to make sure that there is no other dumpster scheduled for the demolition period.
